The purpose of this EEO Public File Report (Report) is to comply with § 73.2080(c)(6) of the FCC's Rules and Regulations. This Report covers the Station Employment Unit comprising noncommercial educational radio station KWSO(FM), Channel 220C2, Warm Springs, Oregon, FCC Facility ID No. 13582 (the Station).

1. KWSO funded a limited duration student position for a high school student through the 2014-2015 school year. Our student increased her capacity to produce and her reliability was outstanding. She had started as a student summer worker and we were delighted to mentor her. Her contributions far outweighed any additional effort we took to train and coach her. She's off to college now – but we hope when she returns from school during breaks – we can put her to work.

2. In 2015 KWSO took on a new high school student under a summer work program funded by health prevention money. She learned the basics of conducting interviews, recording, editing and producing quickly and became our new youth reporter. We are keeping her on our payroll to work in a part time capacity through the school year.

3. KWSO collaborated with a 7th/8th teacher at our K-8 grade school on a student “radio project.” The students created their own radio station concepts, learned to write radio announcements, recorded and learned basic editing. The project concluded with a field trip to KWSO where they recorded station liners and messing about bullying.

4. It is the policy of the Confederated Tribes of the Warm Springs Reservation of Oregon to hire individuals solely upon the basis of their qualifications for the job to be filled and not to engage in unlawful employment discrimination. Further, it is the intent of the organization to give preference in employment and career opportunity to members of the Confederated Tribes of the Warm Springs Reservation of Oregon. Therefore, all other things being equal, tribal members will be considered first to fill vacant positions. The Confederated Tribes will promote tribal-member employment by giving preference to those applicants who are tribal members, provided they meet the minimum qualifications needed to either fill the vacant position or participate in an Affirmative Action training plan.

If there are multiple applicants for a position, and all applicants have similar qualifications, preference in hiring is given in the following order:

- I. Tribal Member of the Confederated Tribes of the Warm Springs Reservation of Oregon
- II. Married In to the Confederated Tribes of the Warm Springs Reservation of Oregon
- III. Native American - not a member of the Confederated Tribes of the Warm Springs Reservation of Oregon
