Dear Tribal Member,

The Election and Counting Boards have re-submitted the results from the April 4th, 2019 Tribal Council election to the Tribal Council for re-certification. The results that were submitted on April 5th had a keying error in the total number of votes a write-in candidate received which was not caught by the Counting Board prior to signing off on the document. Additional concerns were raised by the membership regarding write-in candidates and votes received and the Counting Board worked with election vendor to update each district with this information. The initial report from the vendor included room for three write-ins and thus did not reflect all write-in votes received.

In addition, the Superintendent was notified on April 9th, 2019 that the Elections Board did not check the dedicated post office box that was used for all returned absentee ballots on Election Day. The Election Board should have removed all ballots by 4:30 pm on that day so that absentee ballots could be counted and included in the official results. This did not occur.

The Election Board, in coordination with the BIA Superintendent, removed the ballots from the post office box and spoke with the Postmaster who verified that seven of the 51 ballots would not have made it to the post office by Election Day. Those included ballots that were postmarked on the Election Day and sent from other locations outside of Warm Springs. The remaining 44 ballots were counted and included in the report submitted to Tribal Council today. The additional 44 ballots counted do not impact the outcome of the election in any district.

The recent election was a challenge to both Boards, primarily because of limited Board members and the inclusion of additional absentee polling sites at Simnasho and Seekseequa. The Election Board has 3 members and 2 alternates, however only 3 board members were available and 1 alternate was only available for limited time for the April 4th election. Election Board members are solely responsible for handling ballots, checking the post office box, taking ballots to the WS Detention Center and High Lookee Lodge, and must be on site at all polling locations. Thus, there is a need for additional members to ensure that all tasks are completed in a timely manner. This recommendation has been made to the Tribal Council.
