Section 3: Supplemental (Non-Vacancy-Specific) Recruitment Activities Undertaken By the Station

1. KWSO funded 2 limited duration college student positions. One position was focused on telemarketing and program production that can be underwritten. The other position was on-air announcing, production and reception.
2. KWSO was the worksite for a high school student intern in partnership with the Jefferson County Chamber of Commerce and the Jefferson County 509-J school district. Our student did some voice work but was focused on Graphic Art for use in a coloring book about our community.
3. KWSO participate in the Madras High School career fair in the spring, suggesting possible opportunities for student internships at the radio station.
4. It is the policy of the Confederated Tribes of the Warm Springs Reservation of Oregon to hire individuals solely upon the basis of their qualifications for the job to be filled and not to engage in unlawful employment discrimination. Further, it is the intent of the organization to give preference in employment and career opportunity to members of the Confederated Tribes of the Warm Springs Reservation of Oregon. Therefore, all other things being equal, tribal members will be considered first to fill vacant positions. The Confederated Tribes will promote tribal-member employment by giving preference to those applicants who are tribal members, provided they meet the minimum qualifications needed to either fill the vacant position or participate in an Affirmative Action training plan.

If there are multiple applicants for a position, and all applicants have similar qualifications, preference in hiring is given in the following order:

- I. Tribal Member of the Confederated Tribes of the Warm Springs Reservation of Oregon
