RESOLUTION NO. 13,264

WHEREAS, The Tribal Council is the governing body of the Confederated Tribes of the Warm Springs Reservation of Oregon; and,

WHEREAS, Article IV, Section 11 of the Tribal Constitution and By-Laws of the Confederated Tribes of the Warm Springs Reservations of Oregon, provides that the Tribal Council may select such committees as it may deem necessary to properly conduct the business of the Tribal Council, and in Article V, Section 1 (s), for the appointment of subordinates boards and tribal officials; and,

WHEREAS, There are currently eight such committees including the Culture & Heritage Committee, Education Committee, On-Reservation Fish & Wildlife Committee, Off-Reservation Fish & Wildlife Committee, Health & Welfare Committee, Land Use Planning Committee, Range, Irrigation & Agriculture Committee, and Timber Committee; and,

WHEREAS, The Tribal Council believes that it is important to give the committees clear statement of their purpose, mission, powers, operational guidelines, and responsibilities; and,

WHEREAS, The Tribal Council hereby appoints the committee members to the current term to serve until new committees are appointed 60 days after the next term of the Tribal Council; and,

WHEREAS, The committee members are to take the oath of office on September 9, 2025; and,

WHEREAS, The committee members will receive \$10.00 per hour for their services, with the exception of the Culture & Heritage Committee, who will receive \$10.50 per hour for their services; plus a mileage allowance according to the Tribal Mileage Chart and the Federal Mileage and per diem rates; now, therefore,

BE IT RESOLVED, By the (30<sup>th</sup>) Tribal Council of the Confederated Tribes of the Warm Springs Reservations of Oregon, pursuant to Article IV, Section 11 and Article V, Section 1 (s) of the Tribal Constitution and By-Laws that the Tribal Council shall appoint such committees as it may deem necessary for properly conducting the business of the Tribal Council to membership on those committees as it shall deem appropriate, and the Committee membership shall be as follows;
